    - Scheduled – 20
  - Spill Prevention, Control & Countermeasures (SPCC) Inspections completed –
    - Carryover from FY 16 - 42
    - Brought into Compliance – 11
    - Inspections completed – 15
    - Scheduled – 30

  - Removal Actions Recommended – 2
  - Removal Actions not recommended – 3
  - Removal Support to another program – 1
  - In Progress - 11
  
- 3 Removal Completions (Target 15):
  - 9 Ongoing
  - 6 Waiting start
  - States: CT-5, MA-7, NH-2, ME-1, RI-1
  - Cleanup funding approx. on CR
    - CERCLA \$4.8M (normal 8M)
    - Oil \$1.5M
  - Technical/program support funding
    - \$2M (normal 4.6M)

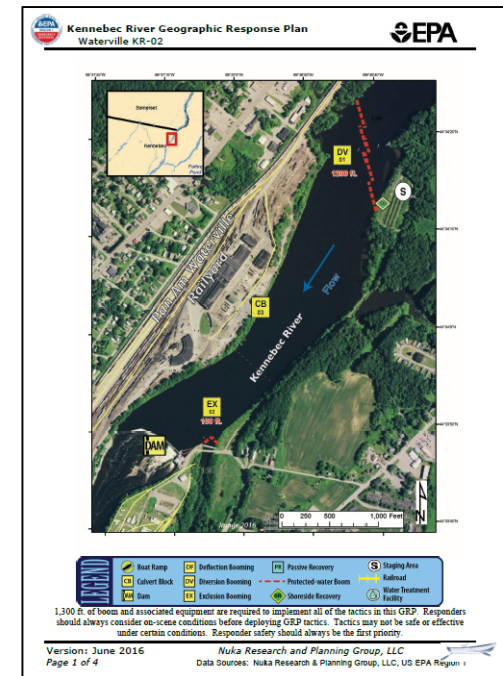






# Projects

# Initiatives

- National Incident Management Assistance Team (N-IMAT)
  - 2 Team Trainings
  - 18-20 October
  - 14-18 November
  - R1 & R2 comprise one of four rotating teams
  - Teams on “callback” 1 month in 4; R1/R2 first callback month 12/2016
  - Mobilize to US location within 48 hours
  
- ICS Institute
