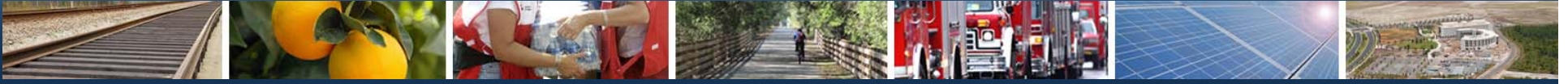

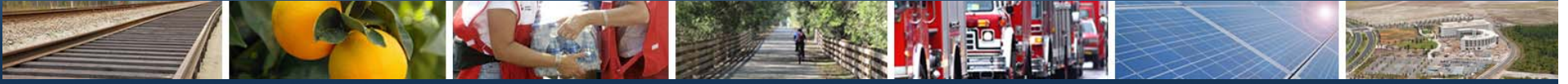

REGIONAL PLANNING COUNCILS

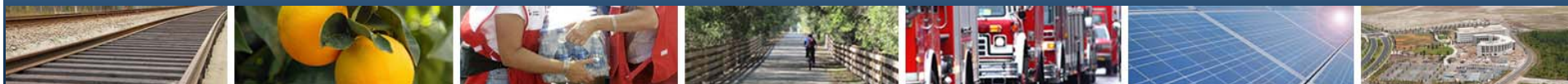


Chapter 186 of Florida State Statutes:

- “...issues of public safety, education, health care, community and economic development and redevelopment, protection and conservation of natural and historic resources, transportation, and public facilities transcend the boundaries of individual units of government...”
- Coordination of an integrated planning system
- Promote intergovernmental coordination, allocation of resources, preservation and enhancement of the quality of life.



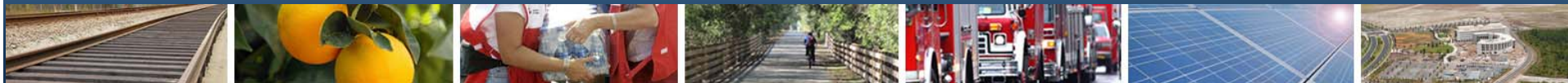
REGIONAL PLANNING COUNCILS



- 10 RPCs in Florida
- East Central Florida
- Eight counties
(Marion, Lake, Sumter, Volusia, Seminole, Orange, Osceola & Brevard)
- Governed by 32-member board
- Entity of the state
- Local government-owned
- Non-profit



SARA Title III



- **Superfund Amendments and Reauthorization Act (SARA)**
- **Response to Bhopal disaster in India and the increasing chemical releases in the United States in the 1970's & 1980's**
- **Title III of SARA enacted the Emergency Planning and Community Right-To-Know Act (EPCRA)***
- **Designed to help communities (at the local level) protect public health, safety and the environment from Hazardous Materials**
- **Requires each state to appoint a State Emergency Response Commission (SERC)**



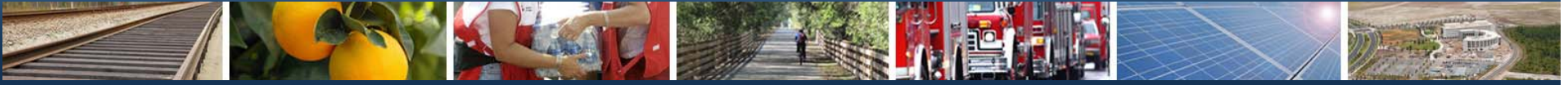
Emergency Planning and Community Right-to-Know Act (EPCRA)



- Established a framework for states to organize resources to pre-plan for chemical accidents:
 - Emergency Planning and training
 - Hazardous chemical inventory reporting
- Facilities are required to report Extremely Hazardous Substances (EHSs) by March 1 using E-Plan
- EHS list (“List of Lists”) of chemicals subject to EPCRA, Comprehensive Environmental Response Compensation and Liability Act (CERCLA) and the EPA Clean Air Act (CAA)



State Emergency Response Commission (SERC)



- ❖ **SERCs are required to divide their states into Emergency Planning Districts and to name a Local Emergency Planning Committee (LEPC) for each district.**
- ❖ **Twenty-three (23) Governor-appointed individuals who represent state government, local government, emergency services, industry and environment.**

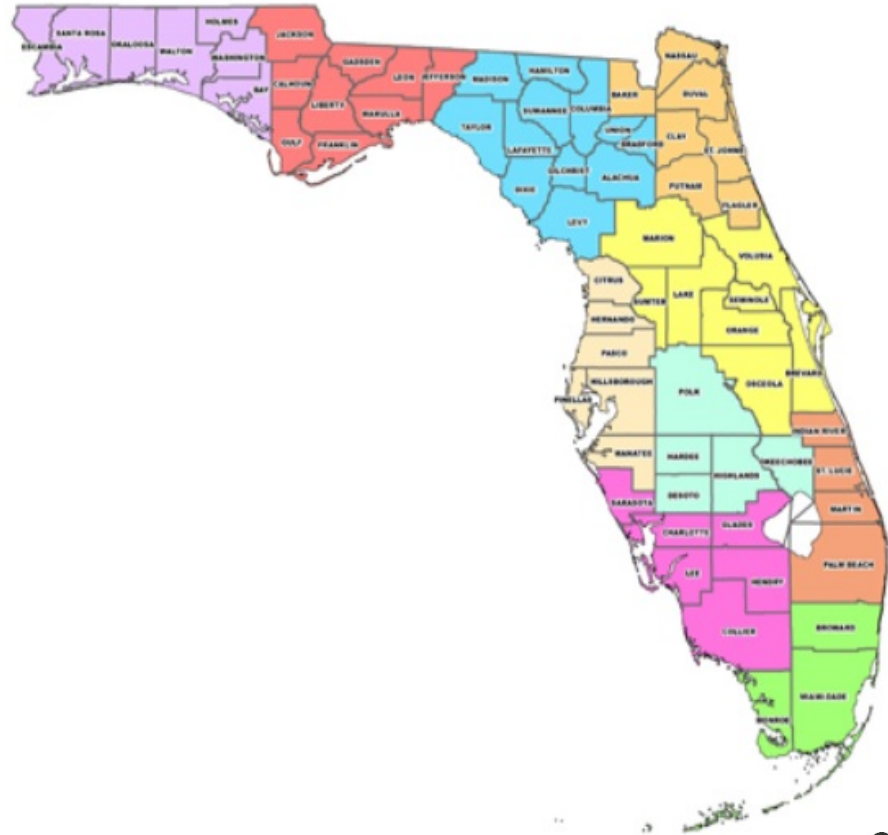

Local Emergency Planning Committees (LEPC)



1. Responsible for preparing a Regional Hazardous Materials Emergency Response Plan
2. Repository for regional Hazmat information (EPCRA law)
3. Perform outreach functions to increase Hazmat awareness
4. Spend grant money for hazmat related trainings, exercises, and projects.



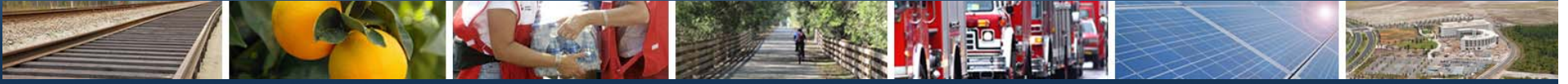

- Provides guidance on spending the Hazardous Materials Emergency Planning (HMEP) federal grant funds issued to LEPCs annually by U.S. Department of Transportation (US DOT) Pipeline and Hazardous Materials Safety Administration (PHMSA)

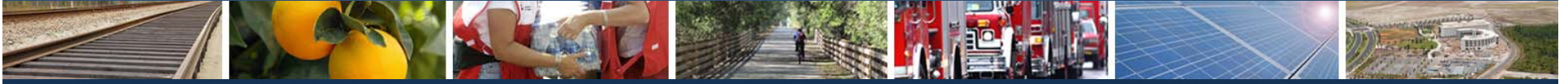
