

 NMFS is in the process of consulting with species experts and our Section 7 biologists to determine if the existing BMPs need to be revised due to the critical status of the NARW population.



NOAA's Paper and Raster Navigational Chart Web Tools to Shut Down

 Beginning in 2021, NOAA will start cancellation of its traditional NOAA paper nautical charts and associated raster nautical chart products, such as BookletCharts<sup>™</sup> and Raster Navigational Charts (RNC) will occur over the next four years and be completed by January 2025.
