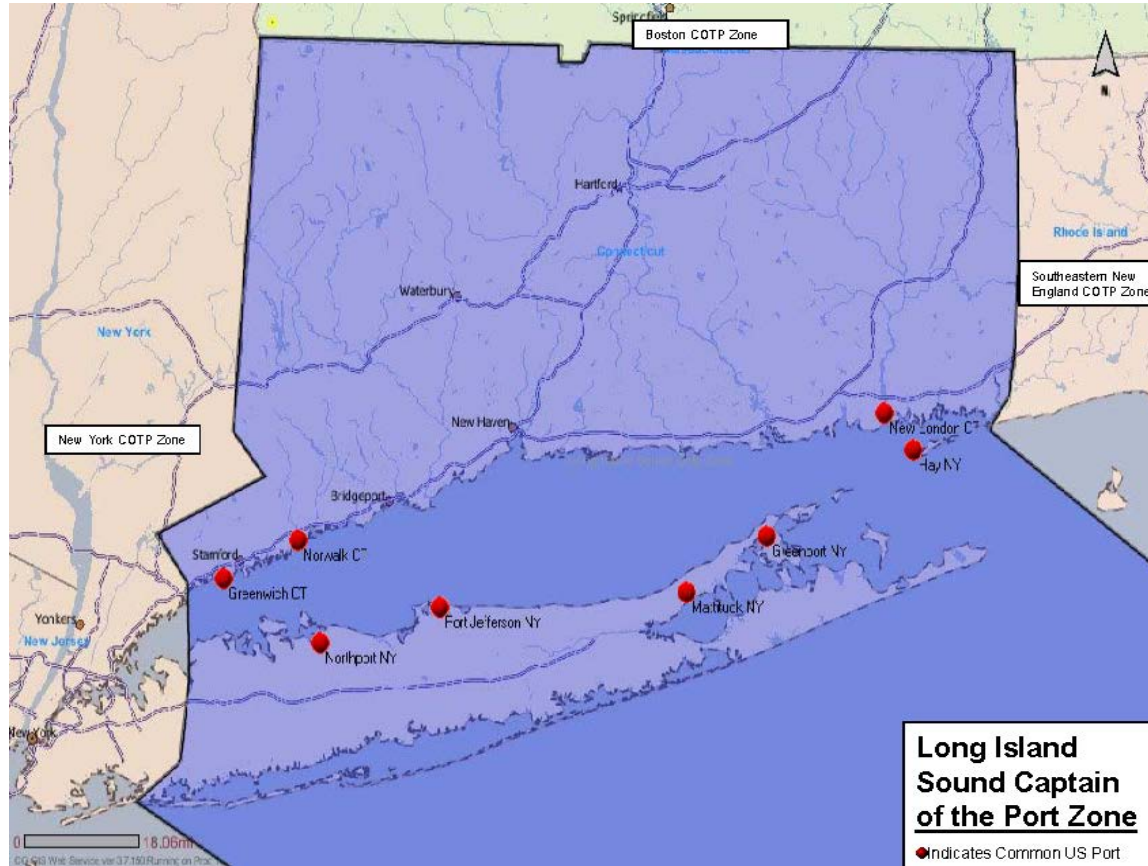

# Derelict Vessels



**Date of Spill:** February 12, 2021 (Case # 1250330)

**Location of Spill:** Freeport, NY

**Type and Amount of Product Spilled:**

Unknown gallons of gasoline  
(25 max gallon potential)

**Cause of Spill:** Accumulation of snow causing capsizing of vessel.

**Other Agency Involvement:** NYDEC

**Concerns:** Cold water and air temperatures making dissipation of product difficult.

**Lesson Learned for RRT 2 attendees:**

Vessel registered in another state by previous owner, but no official transfer of ownership. Registration from 2012.





# NY0381JZ



**Date of Incident:** December 12, 2020

**Location of Exercise:** Mastic Beach, NY

**Type and Amount of Product Spilled:**  
Unknown amount of gasoline.

**Cause of Spill:** Lack of maintenance

**Other Agency Involvement:** Suffolk County Police, NY DEC

**Concerns:** General safety and facilitation

**Lesson Learned for RRT 2 attendees:**

Since the start of COVID-19 there seems to have been an increase in private used boat sales and lack of documentation via bill of sale, current registration, etc. Marinas have eased requirements for proof of ownership/insurance to fill slips.
