- Jackson County, Mississippi
 - Includes Cities from Pascagoula (East) to Ocean Springs (West)
 - Borders Alabama State Line (East) and Harrison County (West)
- Industries Include:
 - Large Oil Refinery
 - Intermediate Chemical Facility
 - Shipyards & Shipbuilding Facilities
 - Ammonia Facilities
 - Agriculture Facility
 - LNG Plant
 - Port Facility
 - Pogy Processing Facility

Funding & Participation

- Funding is always an issue
 - HMEP Grant (typically less than \$10K per cycle). 20% match is usually met with “In-Kind” services vice direct dollars.
 - Industry funded for special projects
 - Other opportunities include:
 - Local ordinances that charge by pound of hazmat or by number of employees to Tier II companies
 - State Tier II fees
- Participation
 - We currently have ~30 members in attendance on a regular basis
 - If you feed them, they will come. Get sponsors for lunch and this cost can be used towards In-Kind match for grants.
 - Exercises are sponsored by industry and response organizations; these costs can be used towards In-Kind match as well.

Preparedness Activities

- Exercises conducted with Singing River Hospital, CSX, Gulf LNG, and First Chemical -- these activities enhance hazmat response capabilities.
- LEPC Sponsored HazMat training for Emergency Responders: this was grant-funded training conducted in county locations for fire, EMS, law enforcement and industry partners.
- Over \$75K in grant money received to the County to help in emergency planning
- One grant of \$50K awarded for plan update that had not been updated since before Katrina

Outreach & Information Activities

- Coordinated informational Public Service Announcement post cards mail out to local area urging sign up with Code Red emergency call out program
- Creating a Shelter in Place Program for our near neighbor schools and daycares.
(over 250 kits purchased distributed to local daycares and over a dozen local schools, both public and private) as well as training and exercises conducted
- Designing and Purchasing Emergency Information Signs to tell community what to do in the event of an emergency chemical release
- Website development with Tier II information
