
Where We've Been

- Special emphasis on common/nested objectives
- Jurisdiction-specific objectives could be exercised in modular approach




Initial Concept Discussion

- Scenario will be a catastrophic hurricane impacting Region III
- Proposed track: landfall vicinity Hampton Roads then northward movement up the Chesapeake Bay coinciding with high tide in Baltimore
- Opportunities for effects in Regions I, II, IV to support independent play
- Multiple modeling resources available to support effects development
- NOAA to develop final weather products to match track and effects to outcomes
