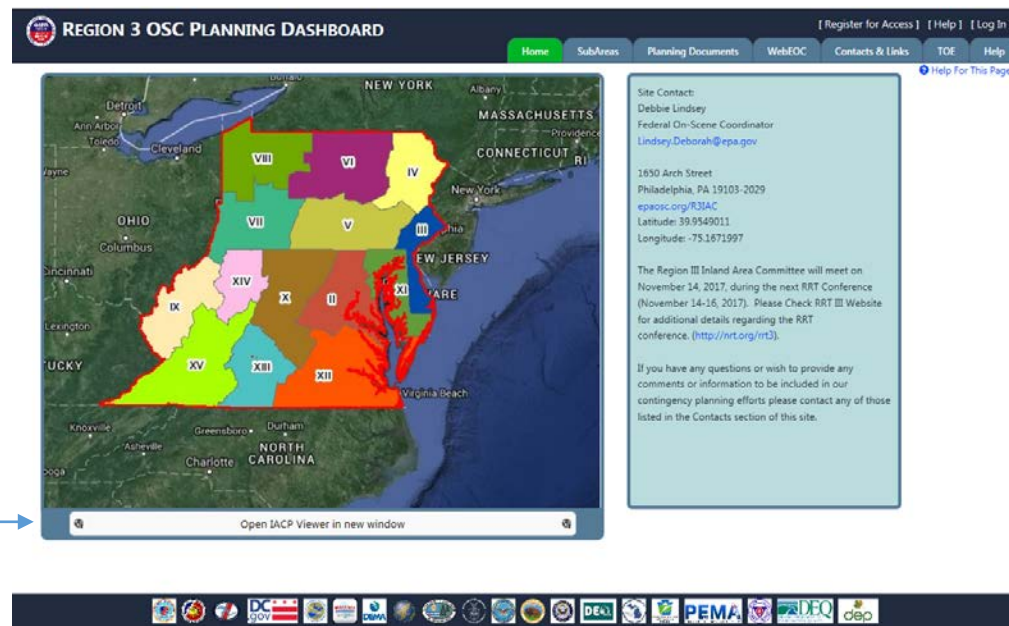

R3 OSC Planning Dashboard

The Region 3 On-Scene Coordinator (OSC) Planning Dashboard is a tool that provides emergency planning resources and data for the Environmental Protection Agency (EPA) in Region 3. The Dashboard makes available to a wide variety of audiences information relating to the 14 EPA Region 3 Sub-Areas, including Sub-Area planning documents, fact sheets, contact information, interagency agreements, data layers in an interactive geographical mapping system, and much more.



Dashboard Access

Register for Access and Log In are located here. Access will be granted based on the security levels discussed below. WebEOC (a web service for EPA Region 3's Emergency Operations Center) and TOE (a application that tracks Training, Outreach, and Exercise) are only accessible by government officials and require a separate log in.

Interactive Map Viewer

Click to open up an interactive map of the Region 3 Sub-Areas. Log In is required to use interactive map.

Data Layers you can find on the interactive map include:

- Emergency Services
- Public Health - Hospitals
- Water - Wastewater Treatment Plants (WWTP) & Dams
- Railroads
- Risk Management Plan (RMP) & Facility Response Plan (FRP) Facilities
- Training Outreach & Exercises
- Schools
- Energy – Power Plants, Oil & Gas Wells, Oil & Gas Pipelines, Refineries
- Sensitive Species Search

Portals

Information is sorted into different portals as shown in the Tabs across the top of the Dashboard: Sub-Areas, Planning Documents, WebEOC, Contacts & Links, TOE, and Help. Each Portal provides information as discussed on page 2.

Different Security Levels

The Region 3 OSC Planning Dashboard has four security levels built in, plus one for Administrative Users that manage the site. Each security level controls a combination of data access and site functionality privileges.

The four levels of secure logins are as follows:

- **Public** (includes public partners and general public),
- **Non-Federal Partner** (includes local government, industry partner, and contractors),
- **Federal Partner** (includes Federal agencies, State agencies, and their contractors), and
- **OSC** (access only for EPA On-Scene Coordinators).

Sub-Areas Information

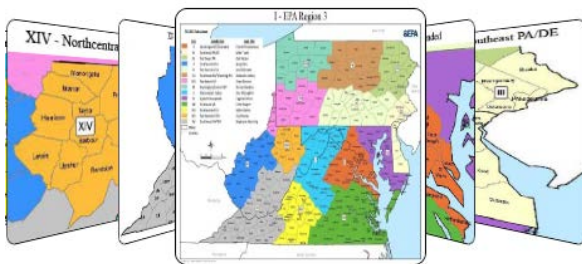
Details about each Sub-Area are provided at this location: Location and Area of Responsibility, OSC Contact information, and Sub-Area Specific Planning Documents.

Planning Documents

All Region 3 planning documents can be viewed and sorted from categories such as: Meeting Minutes, Executive Orders, Memorandums of Agreement/Memorandums of Understanding (MOA/MOUs), Regulations, Response References, Sub-Area Contingency Plans (SACPs), Training Exercises, and more.

Region 3 Contacts & Links

The Contacts & Links tab provides two functions. The Links section on the left gives direct access to relevant links including, but not limited to: Region 3 RRT Website, NRT's Selection Guide for Oil Spill Response Countermeasures, Inland Area Contingency Plan (IACP) Contact Information List, and On-Scene Coordinator Phone Book. The Contact section on the right is a list of registered and non-registered users who are involved in the Region 3 Inland Area Committee and/or Regional Response Team. A "Mail to" capability is also available for registered site users.
